How We Will Calculate Your Balance:

We use a method called "average daily balance (including new purchases)."

Promotional Period for Introductory APR:

The Introductory APR for balance transfers will apply to transactions posted to your account during the first six billing cycles following the opening of your account. Any existing balances on TEG Federal Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

The Introductory APR for purchases and cash advances will apply to transactions posted to your account during the first six billing cycles following issuance of your card.

Loss of Introductory APR:

We may end your Introductory APR for purchases, balance transfers and cash advances and apply the Penalty APR if you are 65 days late in making a payment.

Application of Penalty APR:

Your APR may be increased to the disclosed Penalty APR if you are 65 days late in making a payment.

Other Fees & Disclosures:

Late Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less, if you are two or more days late in making a payment.

Cash Advance Fee (Finance Charge):

\$5.00 or 2.00% of the amount of each cash advance, whichever is greater, however, the fee will never exceed \$25.00.

Returned Payment Fee:

\$20.00 or the amount of the required minimum payment, whichever is less.

Card Replacement Fee:

\$5.00.

Pay-by-Phone Fee:

\$5.95.

Rush Fee:

\$40.00.

Statement Copy Fee:

\$5.00.
